GUIDELINES:

Co-authorship is allowed to the **maximum of two Authors**. The authors should submit their Full Paper on or before 17th April, 2013.

The Paper should not exceed a limit of 5-6 pages not including the abstract. It must be typed in Font size 12, Times New Roman, on A4 size paper with 1 inch margin on all sides with single line spacing using MS Word. A uniform citation pattern should be followed by the Author but we would appreciate the use of Blue Book Style of referencing and footnoting.

Kindly give a Title to your Paper and register at the earliest, so that it may be convenient for the Organizing Committee to categorize your paper.

The Top 10 selected papers will be published in the Conference Book and Top 5 papers would be given a special certificate of merit.
