ABOUT THE ORGANIZERS

Rajiv Gandhi National University of Law (RGNUL), Punjab, was established by the State Legislature of Punjab by passing the Rajiv Gandhi National University of Law Punjab Act, (Punjab Act No. 12 of 2006). The Act incorporated a University of Law of national stature in Punjab, thereby fulfilling the need for a Centre of Excellence in legal education in the modern era of globalization and liberalization.

Punjab Right to Service Act 2011 was passed by the Punjab Government in October 2011. It has empowered people to seek services in a hassle free, corruption free, transparent and time bound manner through different service delivery mechanism. This Act ensures that people take maximum advantage of time bound service delivery system, without any hassle which enhances the credibility of the government functioning amongst people. Punjab Right to Service Commission was constituted as per the requirements of Punjab Right to Service Act 2011. The Commission has been entrusted with the task of making suggestions to the state Government for ensuring better delivery of services.

THEME OF THE SEMINAR

The seminar will focus on objectives of Punjab Right to Service Act 2011 for strengthening the theory and practice of public service guarantee laws across the country. There is a need to create awareness among citizens about their right to a timely service. Such awareness will make the Act binding on the service-providers, warning them against taking a laid back attitude towards service-provision. GUIDELINES FOR SEMINAR PAPER

An abstract should contain 300 – 350 words accompanied by a brief profile of the author indicating his email ID, contact number and official address.

Paper should not be of more than 6000 words. It must be typed in Times New Roman Font Size 12 on A4 size paper with 1” margin on all sides with 1.5 line spacing using MS Word. A Uniform Formatting Style must be strictly adhered to while submitting the abstracts and full paper.
