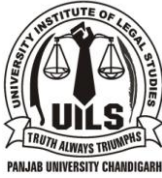

The registration fee for each event is as under:

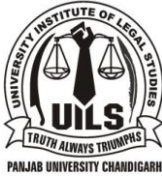
