Articles or Research Papers focusing on developments post 2013 are invited on any of the themes. Paper presentation is not necessary for participation.

- The deadline for abstract is 20th Feb 2016 (Saturday), for full paper 27th Feb 2016 (Saturday)
- Acceptance of the abstract would be intimated in 3 clear days.
- The abstracts should not exceed 300 words (3 small paras).
- It should indicate: 1. Title of Paper 2. Presenter's brief description name, current designation, educational qualification, professional status and experience in 100 words only.

The accepted papers would be given in 10-15 minute time capsule may be less and no more. Whose papers are not accepted they may also attend.

If the paper is accepted for presentation only then certificate mentioning the title of the paper shall be given.

Guidelines for Abstract and Final Paper Submission: (applicable to candidates whose abstracts are accepted)

1. The paper should consist of not more than 6000 words, inclusive of footnotes.
2. Font 'Times New Roman'; Size 12 for Text, 10 for footnotes
3. Line spacing 1.5 for text and single for footnotes
4. Microsoft Word Document Format (No pdf)
5. Author's Title & Name, University/Organization, Paper Title and Email Address to be stated clearly on the cover page of the paper.
