Despite having a strong legal framework for environment, India ranks 177th out of 180 countries in the *Environment Performance Index, 2018*. This shows the utter failure of implementation of the laws to control environmental pollution and degradation as the pollution levels hit a new high and a large population in India has become victim of air pollution, water pollution, hazardous waste, etc.
