



DHARMASHASTRA NATIONAL LAW UNIVERSITY, JABALPUR (M.P.)

Admission Announcement for LLM (2 Year) Programme 2018-19

The Dharmashastra National Law University, Jabalpur is established by Madhya Pradesh Dharmashastra National Law University Act No. 24 of 2018. The University was inaugurated by Hon'ble the Chief Justice of India in the gracious presence of Hon'ble the Union Minister of Law and Justice, the Chief Minister of State of Madhya Pradesh, the Chief Justice of the High Court of Patna and the Chief Justice of Madhya Pradesh High Court on 30th June, 2018.

The University invites applications for admission to LLM (2 Years) Degree Programme for the Academic Year 2018-2019 scheduled to commence from November 2018.

Total seats, eligibility and other details are as under:

- a) **Total Seats** - 30 (Thirty)
- b) **Eligibility**– The minimum eligibility requirement
 - 10+2 years of schooling from a recognized Board/Institute and
 - 5 years integrated BA LLB (Hons.)/BSc LLB (Hons.)/B Com LLB (Hons.)/BBA LLB (Hons.) Degree from any University recognized by the UGC with not less than 60% marks in aggregate (55% in case of SC/ST Candidates).

OR

 - 10+ 2 from a recognized Board/ Institute and
 - 3 year Bachelor's degree from any University recognized by the UGC and
 - 3 year LLB degree from any University recognized by the UGC with not less than 60% marks in aggregate (55% in case of SC/ST Candidates).
- c) **Admission** –
A merit list of eligible applicants will be prepared on the basis of the percentage of marks obtained in the Law Degree. Shortlisted candidate will be intimated to appear for interview at the University. The interview will be held for twenty marks.
- d) **Application Fee** -An amount of Rs.3,000/- shall be charged as application fees from the candidates applying for admission (Rs.1500/- in case of SC/ST). Fees shall be paid online to the account of the University mentioned below:

Note:-

1. Only online applications through www.mpdnl.ac.in shall be entertained.
2. The selected candidate shall be required to submit their original certificates in the office of University for verification and to deposit the total fees from 25th-29th October 2018 (for detailed fee structure – please click on the link www.mpdnl.ac.in/admission).
3. If any candidate fails to deposit fee till the last date, his or her seat shall be transferred to the candidate selected in waiting list as per merit and such candidate shall not have any claim on that seat.

Online Application Process:

- Visit the University website www.mpdnl.ac.in
- Open the “LLM Admission” Notification
- Thereafter fill the online application form including the details of online payment.
- Upload a latest photo in 150X150 pixels. If the Photo specification is larger than the given pixels, applications will not be accepted.
- After successful submission, take a printout of the application form and copy of the acknowledgement.
- Bring the printed copy of the application form and acknowledgement on the date of interview.
- All the original certificates, mark-sheet and other necessary documents should also be brought for verification.
- Candidates should also bring self-attested copy of all these documents.

Process for deposit of Admission Fee:-

The candidate who is selected in the merit list for admission will have to submit for verification, all the original documents relating to educational qualification, domicile, reservation, etc., at University. After verification of documents, the selected candidate will be required to deposit total admission fee till 29th October 2018. The admission fee can be deposited in favour of “Dharmashastra National Law University Jabalpur” by opting any one of the following modes:-

- (1) Through RTGS (Real Time Gross Settlement), or
- (2) By directly depositing the amount in the University Account, or
- (3) Through Demand Draft drawn in favour of “Dharmashastra National Law University Jabalpur” payable at Jabalpur.

Note: - (1) The online payment or payment through RTGS shall be subject to confirmation by Union Bank of India, State Bar Council, High Court Branch, Jabalpur. The candidates are required to take a printout of the 'transaction' and submit the same to the University. The University's fee deposit Account number shall be communicated to the selected candidates.

- (2) The application fee and the admission fee shall be non-refundable.
