#### **EDITORIAL POLICY**

##### **I. Categories for submissions**

- 1.1. **Long Article:** Papers amounting to Long Articles must be between 5000 and 8000 words (exclusive of footnotes) and must engage in comprehensive analysis of the chosen issue, its status quo, any identifiable lacunae, well examined literature available in that area and an original view or original assessment of that issue.
- 1.2. **Short Article/Essay:** This category of papers must be concise (both in scope and conceptualization) and deal with more specific issue, making an easily discernible, concrete and articulate argument. It can also be used to challenge existing paradigms/norms and provide fresh outlook to common problems. It should be within 3500 to 5000 words (exclusive of footnotes).
- 1.3. **Case Comment, Legislation Review or Treaty Appraisal:** Papers in this category are expected to undertake an original and critical analysis of important judicial decisions (preferably recent), legislations or treaties falling within the broad theme. It should be within 2000 to 3500 words (exclusive of footnotes).
- 1.4. **Commentary, Book Review or Short Notes on Contemporary Developments:** Brief Commentary, Book Review or Short Notes relevant to subject matter of journal are invited, preferably within 1500 to 2000 words (exclusive of footnotes). This category includes critical reviews of recent developments in law or policy, books, articles, or even movies.

##### **II. Originality:**

- 2.1. All submissions must be the original and unpublished works of the author. The contributions shall be evaluated on the basis of originality, innovativeness, clarity and technical correctness.

- 2.2. Preference would be given to the submissions made pertaining to contemporary legal issues.
- 2.3. In case of reference to unpublished works, the author shall be deemed to have obtained the permission of the referred author.
- 2.4. All contributions to the journal are peer reviewed by its expert advisory board subject to the editorial approval and test of plagiarism.
- 2.5. Plagiarism in any form shall result in instant rejection of the submission.
- 2.6. Average score of borrowing or reproduction from foreign sources should not exceed 25%, including footnotes/bibliography.
- 2.7. The Editorial Board of Bennett Journal of Legal Studies (BJLS) shall not be responsible for any material that is libellous or scandalous.
- 2.8. The decision of the Editorial Board in this matter is final and binding.

### **III. Format and Mode of submission:**

- 3.1. All submissions must use A4 format, with 1inch margin on all sides,
- 3.2. Use Times New Roman font with font size of 12 and line spacing of 1.5.
- 3.3. All references should be **footnoted** in Times New Roman font size 10 and line spacing of 1.0.
- 3.4. Speaking footnotes are allowed, though heavy usage of speaking footnotes is discouraged. Use of endnotes is not allowed.
- 3.5. All submissions must be in .doc or .docx format. Submissions made in .pdf format or in any other formats shall not be considered.
- 3.6. **All submissions must be through e-mail (jls@bennett.edu.in) and hard copy submissions are not allowed.**
- 3.7. Number of Author: Paper can be co-authored however, a maximum of two authors is allowed.
- 3.8. **Abstract:**
  - 3.8.1. Each manuscript submission must be accompanied by an abstract of not more than 300 words describing the relevant arguments made or conclusions that have been drawn, which should be placed at the beginning of the paper.
  - 3.8.2. The abstract shall not be used for any prior selection of manuscripts.
  - 3.8.3. Non-submission of abstract can serve as a ground for disqualification of the submission.
- 3.9. **Mode of Submission:** Only Online
  - 3.9.1. All contributions and correspondence should be addressed to ‘The Editors,

Bennett Journal of Legal Studies, School of Law, Bennett University.’

**3.9.2.** The manuscript should be accompanied with the author’s name, designation, institute, contact number and e-mail for future reference.

**IV. Footnote Style**

Footnoting or Citation style prescribed under **Blue Book** shall be followed in order to maintain uniformity across submissions.

**V. Copyright Policy:**

The contribution accepted for publication and the copyright therein shall remain jointly with the contributor and BJLS. Any person desiring to use the BJLS’s material for education purposes, research or private study can do so with the prior written permission of the publisher i.e. School of Law, Bennett University.

**VI. Indemnification Policy:**

All contributors while submitting any contribution towards BJLS hereby consent to indemnify School of Law, Bennett University and BJLS towards all claims, suits and consequences based on any claim of copyright infringement or unauthorized use / violation of any right which may arise as a result of their contribution being published in the BJLS.
