KNOW YOUR TRAINER:



Dr. Hingorani was called to the Bar in 1992 and has been imparting advocacy and mediation skills training since 1998. He has taught at institutions in India (such as Indian Law Institute, New Delhi; Delhi University and several national law schools) and abroad (such as Keble College, Oxford; Warwick Law School). Dr. Hingorani has prepared the modules for the Indo-British Project on Advocacy Skills Training, British Council, New Delhi; the ADR preparatory material for the All-India Bar Examination conducted annually by the Bar Council of India; the Mediation Manual for the FICCI as its National Consultant, and the Mediation Rules for the PHD Chamber of Commerce and Industry. Dr. Hingorani has authored the SAGE bestseller, Unravelling the Kashmir Knot, apart from another 45 national and international publications.
