RULES AND REGULATIONS

Symbiosis Law School, Hyderabad

NOTIFICATION

WHEREAS, Symbiosis Law School, Hyderabad, constituent of the Symbiosis International (Deemed University) has announced its **Symbiosis Law School, Hyderabad, CAPSULE COURSE ON INSOLVENCY AND BANKRUPTCY CODE, 2016** to be held from 7th Feb – 9th Feb, 2020 to enable students from all across India to participate and learn the Insolvency and Bankruptcy Code, 2016.

THEREFORE, the Centre for Corporate and Competition Law of Symbiosis Law School, Hyderabad, hereby makes the following rules, namely:-

I. ELIGIBILITY

- 1.1. Students duly enrolled and pursuing full time 5 years or 3 years law course from any recognized institute.
- 1.2 Legal professionals/PhD Scholars looking to specialize in Insolvency and Bankruptcy Code.

II. REGISTRATION PROCEDURE

- The participant shall register by submission of a duly filled form in the prescribed manner (**Refer Annexure-I**) on or before declared date.
- The registration form is required to be submitted online on or before the declared date to cccl@slsh.edu.in
- Registration after the given deadline shall not be accepted, under any circumstances.
- On receipt of the duly filled registration form, the institute shall respond to the participant, acknowledging the receipt.

III. REGISTRATION FEE

- The Registration fee for the course is INR 2,000 (In words – Rupees Two Thousand Only) inclusive of GST @ 18% which includes accommodation, Course Material and food for the days of the course, Wi – Fi and any other facilities provided by the institute to its discretion for Students of 5year/3 year LLB course.
- The Registration fee for the course is INR 2,500 (In words – Rupees Two Thousand Only) inclusive of GST @ 18% which includes accommodation, Course Material and food for the days of the course, Wi – Fi and any other facilities provided by the institute to its discretion for Legal Professionals/LLM Scholars/PhD Scholars etc.

IV. PAYMENT OF REGISTRATION FEE

The registration fee is to be paid through a wire transfer only.

- The required details for the same are contained in Annexure III.
- Any additional charges incurred by the participant while making the wire transfer are to be borne by them.
- All participants must email a scanned copy of the receipt generated on completion of the wire transfer at cccl@slsh.edu.in

V. Evaluation Method

- Every participant will have to sit for an online/offline evaluation in the form of a Multiple Choice Question (MCQ) test, pertaining to the topics taught during the Course.
- A minimum of 50% of the total marks has to be scored by the participant in order to avail the Certificate of Merit.
- Participation Certificate will be given to all the Participants.

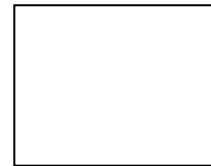
Note: Certificates will be issued to those participants who has 75% attendance in the duration of the course.
